Required Course/Instructional Material Fees must meet certain conditions, per Student Fee Handbook, issued by the Chancellor's Office, January 2004: **"Required instructional and other materials" are defined as materials which the student must procure or possess as a condition of registration, enrollment, or entry into a class; or any material which is necessary to achieve the required objectives of a course.**

General Guidelines for Course/Instructional Material Fee Pricing:

When the **college/district is the only source** of instructional, health or safety materials, the materials provided will be **less expensive to students** than can generally be obtained elsewhere **AND** the **materials provided** will be priced at or below the **college's/district's actual cost**.

Additionally, the college/district can require specific materials when there is a **health or safety*** concern related to an instructional program or course. Specific brands and item type may be required by proprietary equipment for the safe operation of the equipment.

Course/Instructional Material Fee Request Form Instructions:

General Guidelines for Course/Instructional Material Fee Pricing:

When the college/district is the only source of instructional materials, such as class handouts, course syllabi, and other tangible materials the material must be provided to students at a cost less expensive than can generally be obtained elsewhere. Additionally, the materials provided to should be priced at or below the college's/district's actual cost.

1. Describe and itemize each course material fee.
2. Indicated whether the item(s) is/are required because of health or safety concerns.
3. Note the quantity the student will receive throughout the term of the course.
4. Approximate the retail unit price of each item.
5. Compute the estimated cost of each item. (Quantity X Retail Unit Price = Estimated Cost)
6. Total the estimated cost of each item to derive the **Total Course/Instructional Material Fee**.
- Round **Total Course/Instructional Material Fee** downward to the nearest whole dollar or \$.50 amount.
7. When a material fee is established by a department for a course – that fee and those materials shall be provided to students in each section of the course. Material fees forms are part of the official course outline.
